Dorm is mainly for overseas students, and each room can accommodate more than one person (of the same quarantine period). Taiwanese students can apply if in need. Inbound indiv.	Home Quarantine + self-initiated prevention	Quarantine Hotel	3-day home quarantine + 4-day self-initiated prevention	<ol style="list-style-type: none"> 1. Going out is prohibited during the first 3 days under home quarantine. Immediately afterwards, self-initiated prevention measures should be carried out for 4 days. 2. During the self-initiated prevention period, avoid going out. When going out is necessary, a negative rapid test result is required. Entering campus is not allowed. When in public, wear masks at all times and maintain social distance. 3. Avoid going to crowded areas, dining at restaurants, or attending gatherings. 4. Inbound students: with flights landing on/after July 1, 2022, after completing the 7 days at the quarantine hotels, a proof of negative rapid test result within two days of the moving date is required to move into campus dorm. NOT taken 3 vaccine shots: 3-day home isolation+ 4-day self-initiated prevention	<ol style="list-style-type: none"> 1. Going out is prohibited during the first 3 days under home isolation. Immediately afterwards, self-initiated prevention measures should be carried out for 4 days. 2. During the self-initiated prevention period, a negative rapid test result is required to go out (if necessary). Entering campus is NOT allowed. Students can attend classes only after completing this period with a negative rapid test result the next day after the completion. 3. Avoid going to public and crowded areas, dining at restaurants, or attending gatherings. 4. NSYSU Isolation dorm: individual must complete quarantine for 7 days, and going out is prohibited. The dorm is mainly for overseas students, and each room can accommodate more than one person (of the same quarantine period). Taiwanese students can apply if in need. Definition for a high-risk contact: in contact with a confirmed case without mask for over 15 minutes within the last 24-hour period. 2. Required to complete a rapid test when symptoms appear. 3. With notifications from the NSYSU Health Clinic to take a Preventive Leave for 3 days, the individual can either continue to work regularly or work from home, depending on the vaccine shots received. 	Self-Arranged	<ol style="list-style-type: none"> 1. Students: not allowed to attend classes on campus. 2. Faculty and staff: either distance teaching (or make-up classes) / work from home. 	None
Others: <ol style="list-style-type: none"> 1. Individ. who contacted a close contact. 2. Faculty, students and staff under 3-days preventive leave. 3. High-risk staff who has taken three vaccine shots. 	Self-health monitoring	Residence	10 days/ 7days	<ol style="list-style-type: none"> 1. Contact of a close contact: if the close contact is tested negative, the individual can be relieved of the self-health monitoring period. 2.
